- 1) Dr. David Saslowsky opened the meeting by welcoming everyone and reviewed the meeting agenda.

- 8) Planned Workshop: The *Equipping a Diverse and Resilient NIDDK Workforce* workshop will be held at the Neuroscience Center in Bethesda, MD on September 26-27, 2024. The goals of the workshop includes identifying biomedical career paths and skills needed to meet demands of the biomedical workforce; understand how graduate training programs may or may not align with longer term goals of trainees; understand barriers for grad students or early-career scholars, and those from diverse backgrounds and lastly, inform creative strategies for scientific training, networking, mentorship, and sponsorship to provide inclusive support and allow trainees to capitalize on their life learnings.
